

South Glos Parents and Carers C.I.C. understands that your privacy is important to you and that you care about how your personal data is used, so do we. We respect and value the privacy of everyone who visits our website, www.sglospc.org.uk and uses our services and is committed to maintaining it. We only collect, store and process your personal information in accordance with the relevant laws and regulations.

By accessing, browsing or otherwise using our website you confirm that you have read and understood this Privacy Policy. Please ensure you have read it carefully, and particularly the section detailing your rights in relation to the personal information that we collect about you.

Our website may contain links to other websites. Please note that we have no control over how your data is collected, stored, or used by other websites and we advise you to check the privacy policies of any such websites before providing any data to them.

YOUR RIGHTS

You have the following rights under the General Data Protection Regulations, which this Policy and Our use of personal data have been designed to uphold:

- the right to be informed about our collection and use of personal data
- the right of access to the personal data we hold about you
- the right to rectification if any personal data we hold about you is inaccurate or incomplete
- the right to be forgotten i.e. the right to ask us to delete any personal data we hold about you
- the right to restrict (i.e. prevent) the processing of your personal data
- the right to data portability (obtaining a copy of your personal data to reuse with another service or organisation)
- the right to object to us using your personal data for particular purposes
- · the right with respect to automated decision making and profiling

WHEN DO WE COLLECT INFORMATION ABOUT YOU? We collect the following data about you when you:

- register with us as a member we collect this by asking you to complete
 an online membership form on our <u>Join Us page</u>. Or when you complete
 a hard copy of our membership form.
- request to access one of our services/events- For example when you sign up to our training or information events through our website, or at events we keep a register of attendance and your consent to photo/film permission



- give your views on current support and services and future developments - we do this by asking you to complete either an online survey or a hard copy sometimes this may have personal data. You may leave your views through our social media groups. Whilst we collect your views however we will anonymise your name
- provide feedback we do this by asking you to complete feedback forms from our events or training we provide
- use our website website usage information is collected by cookies, please read our section on Cookies.

HOW WE WILL USE YOUR INFORMATION

Our use of your personal data will always have a lawful basis, either because:

- it is necessary for our performance of a contract with you
- you have consented to our use of your personal data (e.g. by subscribing to our database)
- it is in our legitimate interests (i.e. we are interested and connected by Special Educational Needs and Disabilities and your role as a parent carer)

We collect information about you to manage your account with us and to send you information about Special Education Needs and our organisation. For example, if you have joined as a member you will receive our email bulletins, newsletters or communications about Special Education Needs and Disability or information about South Glos Parents and Carers.

When you join as a member - we collect certain information from you so that it helps us understand more about our community that we serve and our reach.

In some circumstances we may collect special category data such as details of medical conditions, nationality, racial or ethnic origin from you.

Specifically, we capture or ask for the following data:

- your name and contact details
- equality information about you (age groups, disability, gender, ethnicity, your role i.e., are you are parent carer?)
- if you are a Parent Carer we collect details on the needs and age range of your child/ren to help monitor what our reach is in the wider community, we do not collect the name of your child unless they attend our Little Treasures group
- depending on which membership you choose we may ask for business/company name, job title/role/profession



- demographic information such as post code, preferences, and interests
- our bank uses your financial information such as credit/debit card numbers when purchasing a service /product from us. PLEASE NOTE WE DO NOT RETAIN THIS INFORMATION
- permission to use photos taken at our groups/events
- IP address/web browser type and version through cookies

Specifically, we use your data for the following purposes:

- to collect statistical information only to help us show our funders who we are reaching. For example; we may have 60% of families who have a child with Autism, 30% have Dyslexia, or we could find we are reaching 100 families in the Yate area and 25 families in Bitton. Nothing that we produce in a statistical format will personally identify any of our members
- to hold attendance records so we know how many people we are reaching and whether we have permission for photo/film consent
- to supply you with information/emails that you have opted into (you may unsubscribe or opt-out at any time) about other services which we think may be of interest to you that is SEN and disability related
- to reply to emails from you
- to personalise and tailor our information about our services to you
- for marketing purposes re our organisation with your permission, we may also use your data for our own marketing purposes which may include contacting you by email. We will not, however, send you any unsolicited marketing or spam and will take all reasonable steps to ensure that we fully protect your rights and comply with our obligations under the GDPR and the Privacy and Electronic Communications (EC Directive) Regulations 2003.

We collect "Other data" through a variety of sources. One of our sources for Other Data is cookies and other technologies that record Data about the use of our website

- Cookies help us collect statistics about: data on traffic, user numbers, sales, and other information. All such data will be anonymised and will not include any personally identifying data.
- **Browser and device data**, such as IP address, device type, operating system and Internet browser type, screen resolution, operating system name and version, device manufacturer and model, language, plug-ins, add-ons and the version of the Services
- Transaction data, such as purchases, purchase amount, date of purchase, and payment method



CHOICE AND ACCESS

You have choices regarding our use and disclosure of your personal data.

Once you have consented to be a member of SGPC you will receive various bulletins and update to latest news. Should you change your mind, you can easily unsubscribe at any point either by clicking on the unsubscribe link in the footer of the email or by sending us a message to Team@sglospc.org.uk

When you submit personal data via our website, you may be given options to restrict our use of your data (i.e. Prefer not to say on our membership form or not accepting cookies on our website).

Your right to withhold information - You may access all areas of our website without providing any data at all however you may need to restrict your use of cookies in order to do this. (Please see cookies section further down the page) However, to use all features and functions available on our website you may be required to submit or allow for the collection of certain data.

Access to your information -You have the right to request a copy of the information that we hold about you. We will respond within 30 days. Or you can look at the footer of our emails and check your profile details which will show what information you have provided us. Or simply <u>email us.</u>

HOW AND WHERE DO WE STORE YOUR DATA

We do not keep your personal data for any longer than is necessary in light of the reason(s) for which it was first collected. Data retention will be determined on the following basis:

Membership data will be held as long as you are a member of our group however if you ask to leave our group we will ensure all your data is deleted from our membership within 30 working days.

Attendance data is stored along with photo/film consent on our records this will saved for 3 years and then deleted

Data security is very important to us, and to protect your data we have taken suitable measures to safeguard and secure data collected through our organisation. We only use organisations that are data compliant to record/store our data, these are as follows:

 main database and communication/marketing emails - we use Mailchimp, you can access their privacy policy <u>here</u>



- online surveys we use Survey Monkey. You can access their privacy policy <u>here</u>. We set up our surveys so that they are anonymous, and we switch off recording your IP address.
- our own data is stored on our online cloud system PCloud. You can access their privacy policy here
- Facebook, is used to collect parent carers' views and we have a separate social media policy that is available on our Facebook groups
- our website is a Squarespace website. You can access their privacy policy <u>here</u>
- we use Stripe payments through our website. You can access their privacy details <u>here</u>
- We use Eventbrite to book events. You can access their privacy policy here

DO WE SHARE YOUR DATA?

We will not share any of your personal data with any third parties unless we have separate permission to do so from you.

In certain circumstances, we may be legally required to share certain data held by us, which may include your personal data, for example, where we are involved in legal proceedings, where we are complying with legal obligations, a court order, or a governmental authority.

The statistics that we use, and share, are always anonymised.

TRANSFERRING YOUR INFORMATION OUTSIDE OF EUROPE

Some of the information you may provide may be transferred to servers within the European Union ("EU") or countries and companies designated as adequate under the General Data Protection Regulation and provide similar protection to those located in the UK. For example survey monkey (online feedback), PCloud (online secure storage system), Squarespace (Website) We always use organisations that complies with the EU-U.S. Privacy Shield Framework as set forth by the U.S. Department of Commerce regarding the collection, use and retention of personal information transferred from the European Union to the United States.

If you use our services while you are outside the EU, your information may not be governed by legislation to the same standard and we are not able to guarantee the security of your information.

COOKIES

Our website uses cookies to better your experience while visiting it. Cookies are small files saved to the user's computers' hard drive that track, save and store information about your interactions and usage of the website.



Where applicable this website uses a cookie control system allowing the user on their first visit to the website to allow or disallow the use of cookies on their computer/device.

This website uses tracking software to monitor its visitors to understand better how they use it and to help us improve it. This software is provided by Google Analytics and Square Space Analytics which uses cookies to track visitor usage. The software will save a cookie to your hard drive, in order to track and monitor your engagement and usage of the website, but will not store, save or collect personal information.
